Dear Sir/Madam,

The Biggest Tax & Business Reform post independence introduced w.e.f July 1st, 2017 has recently completed one year. It has already brought a transformational change in the way business is conducted in the country and is resulting in increasing the economic growth & development of India.

The initial teething troubles have given way to smooth day-to-day operations. The GST Council and the Government have been proactive in making the necessary changes and tweeks to ease the challenges faced by businesses. Numerous clarifications and notifications have been issued in the first year for this purpose.

With the first financial year coming to an end, businesses are rapidly preparing for the year end activities of filing Annual Returns and GST Audits. The Government has recent notificed the Annual Returns (Forms 9 and 9A) and the GST Audit form (Form 9C – Reconciliation with Certification).

Annual Return

The Annual Return comprising of six sections requires the businesses to report information relating to outward supplies as well as inward supplies, input tax credits claimed, adjustments made, tax liability, demands and refunds as well as determination of differial liability.

GST Reconciliation and Audit Certification

The Annual Return prepared by the businesses is required to be reconciled with the books of account. A detailed reconciliation required to be prepared and submitted. The reconciliation is required to be certified by the GST auditor alongwith a certication on his / her observations thereto.

It is expected that businesses will face challenges in preparing the Annual Return as well as the Reconciliation. GST Auditors will also require various inputs, information and reports so as to enable them to undertaken the audit and certification.

With a view to guide the members in preparing for these requirements, IMC Chamber of Commerce and Industry is organising a Workshop **"GST ANNUAL RETURN AND AUDIT"** – **PREPARATIONS BY TRADE & INDUSTRY"** to deliberate on the requirements. Preparations and the practical Issues arising from the Annual Returns and GST Audit.
