INCLUSIVE INNOVATION - THE THEME

An innovation that meets the test of "Affordable Excellence" is "Inclusive innovation". It means making available high quality products or services with affordable access for large sections of the society and while doing so, creating livelihood and access opportunities for the excluded population of the society on a sustainable basis.

Simply put, inclusive innovation means "more from less for more and more people".

IMC INCLUSIVE INNOVATION AWARDS

THE OBJECTIVE

The aim of the Awards is to identify and support work of entrepreneurs, start-ups who are in the process of building enterprises that focus on products or services which are of high quality and yet, affordable and accessible to all sections of the society, especially those leading to growth and development of the population at the base of the economic pyramid, while ensuring commercial viability of the venture.

The Award eco-system seeks to recognise and catalyse the creation of enterprises addressing the theme of inclusive innovation.

THE AWARD CYCLE

2017 is the fourth cycle of the Award. The first three cycles, 2012, 2013 and 2014 evinced high level of interest and participation by inclusive innovators from across the country. Details of the Five Nominees for the three cycles of the Awards are in the brochure.

The Winner of each Cycle received the Award amount of ₹ 20 Lakhs helping them in taking their start-up ventures forward. Two special Awards of ₹ 1 Lakh each were presented in the 2013 and 2014 cycle to four nominees too. A ₹ 2 Lakh GEN Z category award was introduced in the age group of 13-23 years. IMC Inclusive Innovation Cell provides the mentoring support to the Nominees for the Awards.

- Public listed entities and their holding companies, subsidiaries, associates or joint ventures
- Other Public and private companies having turnover of ₹ 10 Crore and above for the Financial Year ended 31st March, 2017
- Government/Government Departments
- Public Sector Enterprises

Category C

- Non - Government Organisations/Not for Profit Organisations (NGOs /NPOs)
- Academic/Research Institutions

GEN Z Category (Age Group -13 to 23 years)

ELIGIBILITY

All persons of Indian origin, from within or outside of India, are eligible to participate.

All innovations are eligible including:



Technology Innovation



Business Process Innovation



Workflow Innovation



Organisational Innovation



Supporting Environment Innovation

The product or service capable of commercial exploitation and scalability will be considered for the Awards.

The product or service could be under development, developed or could be in the market. If the product or service is already in the market, preference will be given to those which have not been commercially launched prior to **1st January, 2017**.

An applicant, who has been declared a Winner (received the prize money of ₹ 20 lakhs) in previous IMC Inclusive Innovation Award Cycles, will not be eligible to reapply for 2017 Awards Cycle for the same innovation.

The short-listed nominees who were invited for interactive session with the Jury (other than the Winner of ₹ 20 lakhs) may reapply for the same or other innovations for the 2017 Cycle of the Awards.

EVALUATION OF THE ENTRIES

Evaluation of the entry will be done on the following criteria:

- Innovation of the product/service
- Scalability of the business venture
- Impact on the society at large
- Affordability of the product/service
- Sustainability of the product/service & venture

A product or a service which is at the stage where it can be commercialised and/or scaled up will be given preference.

TIMELINES

The Awards will follow the following timelines:

• Selection of up to 5 nominees for final interactive session with the jury	December, 2017
• Determination of Awardees/ Awards Presentation	January, 2018

The product - Modified Walker with Adjustable legs has spring-loaded self-locking front legs. When the user pushes the front legs on the upper stairs and the rear legs rest on the lower stairs, the walker is stable enough for climbing stairs. It also has a foldable seat that can be pulled out for resting and is fitted with a horn and a light. It adjust to all sizes of stairs and can be used for climbing and descend. The product can be used regardless of their heights and weights.

The Gearbox is made from light aluminium alloy and enables the use of diesel engines in fishing boats. It has a Z drive which can be locked at 90 degrees while landing of the boat which enables smooth landing of it, without any damage to the nets of the fishermen. The Gearbox is approved by Matsyafed, the Kerala State Co-operative Federation for Fisheries Development.

Avani Pine Needle Gasifier system turns the destructive energy of pine needles into productive energy to be consumed by rural households and to be pumped into the grid. It serves the purpose of India's growing energy needs from renewable sources. It has a potential to generate 750MW capacity power providing powered regimen to potentially 7.5 million rural families in tail-end grid.
