GST, the biggest indirect tax reform post independence introduced wef 1/7/18, has significantly by impacted trade & industry. One of the important objectives & expectation from GST was to bring certainty in tax incidence & minimise tax litigations.

Post 1/7/18, large number of AAR have been issued by different states & there are many court rulings on GST. In some cases, contrary views have been expressed, by different AAR Further, some of AAR seem to unsettle the settled position under indirect tax regime prior to 1/7/18.

Recently, SC (Constitution Bench) has delivered a ruling in Dilip Kumar & Co holding that, in case of ambiguity in interpretation of Exemption Notification; benefit of doubt should go to the Dept & not the tax payers.

The above judicial / AAR developments are likely to significantly impact trade & Industry. Hence, IMC has planned this workshop, wherein Experts would analyse the recent important judicial rulings / AAR & its impact on businesses. Workshop would be in particular, useful to Finance / Tax Executives from Trade / Industry & Tax Professionals.
