#### **I ABOUT THE EVENT**

GST is the biggest tax reform post-independence, which is set to replace, the complex indirect tax regime currently being administered by the Centre, States and Local Authorities. GST is not only a tax reform but a business reform, which as per study conducted by National Council of Applied Economic Research, if implemented in the true spirit could boost GDP anywhere from 0.9% to 1.7%.

Regulatory reforms require studied & thoughtful considerations. The biggest challenge for GST and for the Trade and Industry is determining how this array of regulatory activities will affect their organisations and, as a result, anticipate the imminent changes they need to make and those they can put on a long term plan. Tax Regulators would focus towards the revenue neutrality of the tax rate, increasing investments, risk management in terms of revenue leakage, and capital management.
