#### The key takeaways from the event for participants would be following but not limited to:

- 1. A brief introduction of what is MSME and how this definition has been amended due to the pandemic. The change in the definition, as more and more enterprises have been brought under the umbrella of the MSME Act, allowing them to avail of the Government's schemes and the dispute redressal mechanism under the Act. The session will also cover discussions on the process for registration of MSMEs..
- 2. Role of the banking sector in the revival of MSMEs. With advanced, Government-assured credit facilities being made available and amendments to the Insolvency and Bankruptcy Code, 2016, the banking sector will take a prominent role in the restoration of MSMEs. The session will discuss how MSMEs may avail of the credit facilities as announced by the Government.
- 3. The session will give the participants knowledge on the ways to preserve and protect their businesses and also different methods of recovery of money, other than the reliefs available under the MSME Act.
- 4. The session will also cover with a practical discussion on the real issues being faced by MSMEs in the COVID-19 environment, to enhance an understanding of the same.

Each session will be followed by a short **Q & A round**, by guiding us how to be ready for riskmanagement in terms of phased re-starting of business operations and for structural changes in business activities. During **the Q & A sessions**, the participants will be able to **openly discuss their issues with the panellists** and will be able to seek first had feedback and answers from the esteemed speakers who are from the industry sector as well as the legal fraternity. This will help the participants be able to gain knowledge **on the problems faced by the industries as also seek solutions to the issues faced by them.** 

There will be a 10 minute break out session in separate break out rooms for one on one interaction with other participants and speakers.
