Insolvency & Bankruptcy Code is formulated to consolidate and amend the laws relating to reorganization and insolvency resolution of corporate persons, partnership firms and individuals in a time bound manner for maximization of value of assets of such persons, to promote entrepreneurship, availability of credit and balance the interests of all the stakeholders including alteration in the order of priority of payment of Government dues and to establish an Insolvency and Bankruptcy Board of India, and for matters connected therewith or incidental thereto.

This Act aims at promoting investments, freeing up banks' resources for other productive uses, boosting credit markets and improving ease of doing business in India. It attempts to simplify the process of insolvency and bankruptcy proceedings.

This Act also seeks to balance the interest of all the stakeholders including alteration in the priority of payment of government dues. It also looks forward to exercise regulatory authority over insolvency professionals, insolvency professional agencies and informational utilities.

IMC therefore is holding this Seminar in order to allow the participants to understand the provisions, amendments of this Act in details and interact with each other with a view to achieve more effective implementation of the provisions of law. We expect a large gathering of leading professionals like senior representatives of Companies including CEOs, CFOs, MDs, Advocates, Company Secretaries and Chartered Accountants to attend this Seminar.
