Mediation is a resolutionary process whereby the Mediator, a trained neutral person, facilitates a conversation between disputing parties and supports them in understanding each other's interests and concerns so as to be able to negotiate amongst themselves a mutually acceptable agreement. Mediation is an art as well as a scientific process. Realizing the importance of the mechanism, the Judiciary in India has taken steps to encourage Mediation as an ideal process for resolving disputes and thereby reduce the burden of pending cases in courts in India. The success of the Mediation process depends upon the ability and skill of the Mediator in collaboratively engaging the parties in this process so as to create an environment that encourages a meaningful dialogue focused on addressing the concerns and interests of the disputing parties. The intent and content of the workshop is to give the Participants a hands-on experience in learning the basic skills of a mediator. It will hence enable the participants to not only understand Mediation as a process, but will also afford them the opportunity to systematically learn the role of the Mediator so as to be able to grasp the concepts, learn the techniques and practice them.
