**OBJECTIVES**

Mediation is a resolutionary process whereby the Mediator, a trained neutral person, facilitates a conversation between disputing parties and supports them in understanding each other's interests and concerns so as to be able to negotiate amongst themselves a mutually acceptable agreement. Mediation is an art as well as a scientific process. Realizing the importance of the mechanism, the Judiciary in India has taken steps to encourage Mediation as an ideal process for resolving disputes and thereby reduce the burden of pending cases in courts in India. However, Mediation has been found to be extremely useful in assisting parties to resolve their disputes even without going to any court. The purpose of this training is to afford participants the opportunity to acquire for themselves the skills that go into the making of a Mediator.

The Workshop will be conducted under the auspices of the **Mediation and Conciliation Committee** of the IMC by its Chairman **Mr. Prathamesh D. Popat**. Attendance at this workshop will allow more fruitful participation in the advanced mediation workshops to be organized by **the Mediation & Conciliation Committee** from time to time.

## ABOUT THE TRAINER

**Mr. Prathamesh D. Popat** is a Counsel & Mediator and is the Founder of **Prachi** (Professional Resolutionary, Academic & Conflict Handling Initiatives). He started his law practice as a Counsel in the Chamber of Aspiandiar P Chinoy at the Bombay High Court. After having taken his Accreditation as a Mediator from LEADR (now Resolution Institute), a peak Dispute Resolution organization based in Australia, he continues to expand his understanding and grasp of the field of amicable dispute resolution by regularly taking further, advanced trainings from several leading institutes across the globe, including the “Train-the-Trainers” Workshops.

He is an empanelled Mediator in several institutions, including the Bombay High Court and mediates disputes referred to him directly as also by various courts. He regularly trains professionals, students and others in the art of Mediation & Conciliation. He is a certified Mediator of IMI (International Mediation Institute) based in The Hague. He has authored several articles on Mediation and is the author in the Monograph Series publication of the CTC (Chamber of Tax Consultants) on the topic of Mediation & Conciliation. He is also a contributor to 3 books: (a) IBA’s eBook on Mediation, (b) The Variegated Landscape of Mediation – A Comparative Study of Mediation Regulation And Practices In Europe And The World and (c) Stories Mediators Tell – World Edition. In addition, there will be other eminent faculty members during the course.

## WORKSHOP OVERVIEW

The success of the Mediation or Conciliation process depends upon the ability and skill of the Mediator or the Conciliator in collaboratively engaging the parties in this process so as to create an environment that encourages a meaningful dialogue focused on addressing the concerns and interests of the disputing parties. The intent and content of the workshop is thus to give the Participants a hands-on experience in what it means to wear the mediator’s hat and what goes into become a neutral in a collaborative process. It will enable the participants to not only understand Mediation and Conciliation, but will also afford them the opportunity to systematically learn the role of the Neutral so as to be able to grasp the concepts, learn the techniques hands-on, practice them and get feed-back thereon.

The workshop will be highly interactive and will comprise of presentations, discussions, exercises, demonstrations & role-plays. In order to ensure individual attention to each Participant at the relevant stages, the participant strength shall be restricted in keeping with the available logistics, and in any event no more than 12 Participants.
