Six Sigma helps you eliminate those defects so you can consistently and profitably produce and deliver products or services that meet and exceed your customers'	• The Six Sigma methodology reduces variations in business processes. It seems obvious, but you can't consistently produce a high quality product or service (your output) if you have variations in your processes
